

**OUTING GUN CLUB

\* **7:18 PM** – Meeting was called to order by Secretary, Connie Glass in the absence of Bob O'Brien.

\* There were 7 Members present at this meeting (4 Board of Directors and 3 Members)

\* Secretary's Report: The minutes from the July 8, 2009 meeting were read by Connie Glass. Motion was made by Doug Harran and 2<sup>nd</sup> by Don Littleton to approve the Secretary's report as read. All voted in favor.

\* Treasurer's report was read by Doug Harran. As of September 30, 2009, we had a checkbook balance of \$14,580.00. (With the following checks being written in October to date: Reddings for special firearms - \$1,650.00, Lake Country Foods for Turkeys, etc. – 90.41, Shamrock for Trap League plaques – 293.94, Connie Glass for reimbursement of raffle tickets and door prize tickets - \$37.73, Postmaster for postage - \$88.00. Motion was made by Don Littleton and 2<sup>nd</sup> by John Popehn to approve the treasurer's report as read. All voted in favor.

\* Motion was made by Don Littleton and 2<sup>nd</sup> by John Popehn to approve the payment of the balance due at Lake Country Foods (Banquet Food, etc.) the amount is unknown at this time. All voted in favor.

\* Old Business: Discussion was held on the progress of the Gun Raffle tickets being sold. We have had a lot of help in selling raffle tickets from both businesses and members this year – Thank you everyone! We will have members of the club start to sell raffle tickets for the Two (2) Special firearms (the \$10.00 tickets that can only be purchased that night) at 5:00 pm. at Granny's Bar and Grill.

Don Littleton and Arnie Glass offered to pick up all of the firearms and deliver them to Granny's around 12:00 – 1:00 pm on Saturday, November 7<sup>th</sup>, 2009 to get set-up for the Raffle that evening and to continue to sell the \$5.00 Raffle tickets.

We also discussed who was going to pick up door prizes and from what businesses. To date, we have several hats and gift certificates from local businesses.

Discussion was held on the Trap Banquet and the sponsorship plaques. Motion was made by John Popehn and 2<sup>nd</sup> by Doug Harren that we re-do the sponsorship plaques that did not have the individual names on them and that we order the Four (4) plaques for the Business/Personal sponsors that did NOT receive one at the banquet; therefore, ALL sponsors will receive a plaque. All voted in favor.
